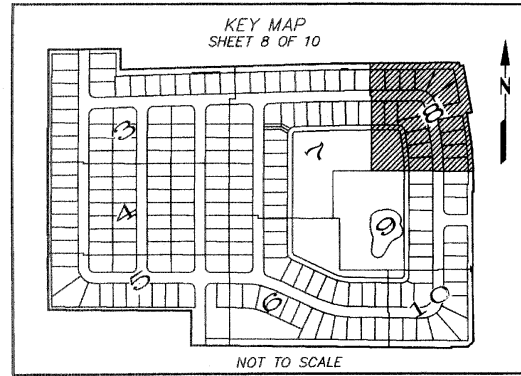


# PALMETTO ESTATES

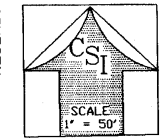
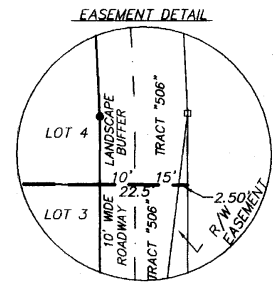
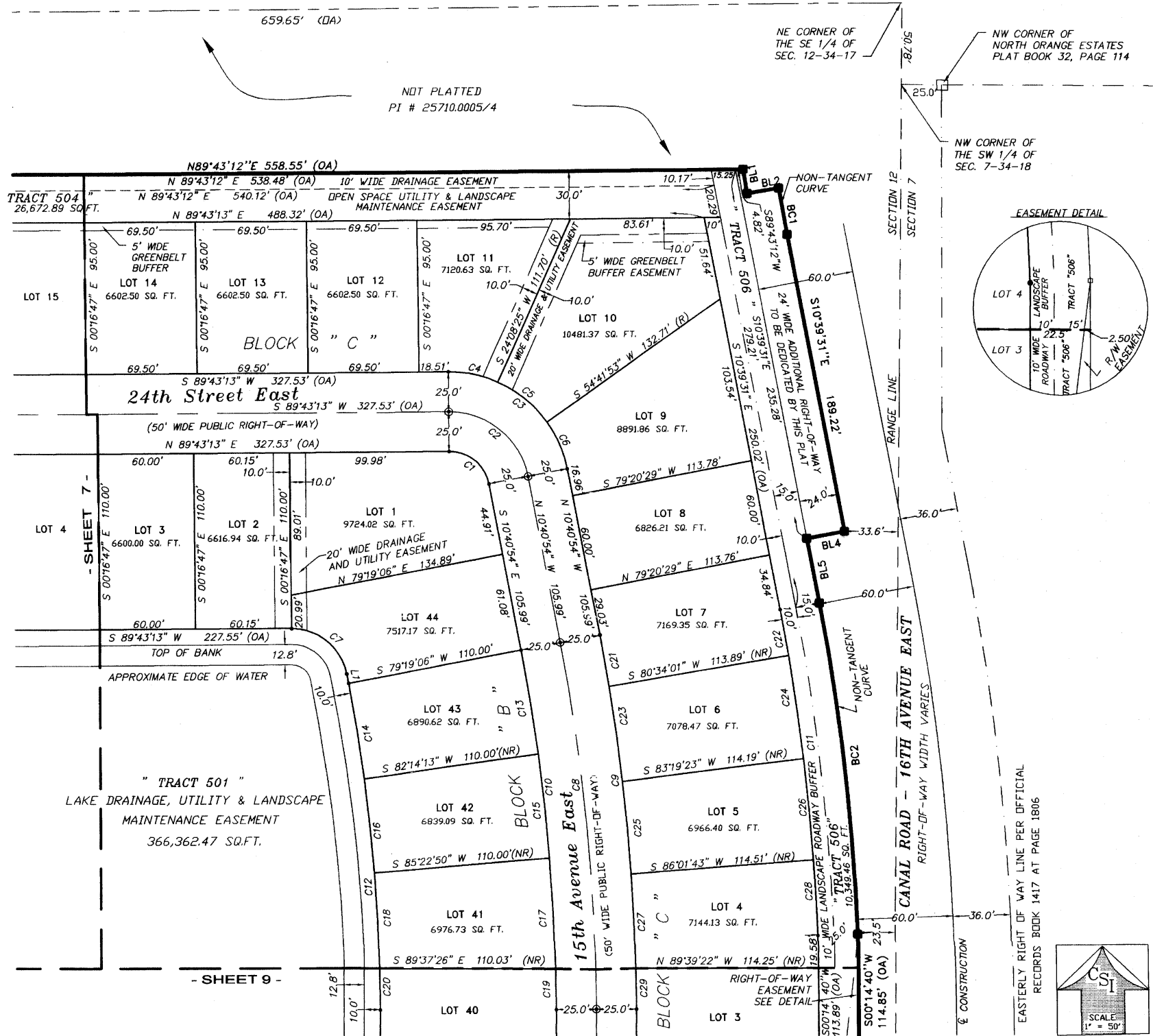
